Youth-specific housing/homeless resources with eligibility information

- Basic Center Program Prevention
 - o 12-17 year olds at risk of running away or being pushed out of the home
 - Goal is to keep the family together and prevent the youth from entering DCF custody
 - Services include: family counseling, case management
 - o Parental/guardian permission required
- Basic Center Program Shelter
 - o 12-17 year olds who have runaway or been pushed out of their home
 - Goal is to help them reunify with their family and prevent youth from entering DCF custody
 - Services include: short-term shelter (host homes or residential setting), case management, family counseling
 - o Parental/guardian permission required
- Transitional Living Program
 - 16-21 year olds who are at risk of becoming homeless or are already homeless
 - At-risk of homelessness includes: youth living independently whose housing is jeopardized for any reason and youth living with family but are likely to become homeless due to the imminence of
 - o Couch-surfing youth are always eligible
 - Services include: case management, access to transitional apartments or rental assistance (up to 18 months)
 - Parental/guardian permission required if youth is under age 18 and not emancipated
- Youth Development Program
 - o 16-21 year olds who have been in DCF custody
 - Some services only available to youth if they were in DCF custody on or after their 16th birthday
 - o Some services only available to youth if they are already 18 years old
 - Housing-specific services include: extended foster care (beyond age 18), financial support for adult-living partners, short-term rental assistance (usually less then 6 months)
 - Other services include: case management, financial support for nonhousing related needs
- Family Unification Program: Youth in Transition
 - Program administered by Vermont State Housing Authority
 - A youth may qualify for an 18 month Housing Choice Voucher if they are currently working with the Youth Development Program, are referred by their case manager, and meet standard definitions of homeless or at risk of homelessness
 - Youth qualify for a preference with VSHA when the 18 month voucher ends, allowing them to potentially get a permanent voucher
