Dear CoC Project Recipients/Subrecipients and all Entities:

During the Tuesday, October 20<sup>th</sup> VCEH meeting, the VT BoS CoC will **vote** on a revised *Project Ranking Policy & Tool* (see attachment) AND the *full slate of projects* below as submitted to the Collaborative Applicant (VSHA); there were no contested funds/projects.

On Oct. 22, the Ranking Committee will prioritize projects for submission to HUD; and may deem it necessary, as the result of poor performance or other factors, to implement selective cuts using the HUD "Hybrid Approach" used by the VT BoS CoC during the FFY2013 NOFA cycle.
