 - (c) HMIS \$59,000

- iii) Current ranking tool lacks consideration of Coordinated Entry/HMIS

 - (2) Coordinated Entry determined 1 full-time staff per local CoC is needed (current funding need 3 local CoC positions)
 - (3) ICA HMIS part-time 20-25 hours/week data analyst (local HIC/PIT reporting, custom reporting), includes coordinated entry
- iv) Considerations for ranking
 - (1) TA provided feedback on scoring configuration (recommended Permanent Support Housing as bonus project would be 60 points)
 - (2) Option to divide total funds among three "new project" applicants
 - (3) Funds for HMIS/Coordinated entry only available for reallocation
