 - Additional information from ESD on upcoming changes:
 - O The question was, is the 80-day count only for the head of household member that the reservation is in or the ESD case is in, meaning that the other adult would have an additional 80 days to be used. The answer is no, a household is a unit and even if the adults were to separate whatever number of days the adult has used with someone else is counted towards their 80 days.
 - O The other question was what we might be able to share with partners as we get closer to September 15th and 19th on who we expect to no longer have access to a motel room, and we are looking what we would be able to pull together and will loop back once we have a seen what data we can pull.  - The majority of the funding went towards rental assistance, security deposits, and rental arrears for survivors relocating to safe housing.
- 10:30 2024 CoC Program Grant NOFO Rundown: Upcoming dates & other information. Abby Miller, Housing Innovations
 - The 2024 CoC Program Grant NOFO officially dropped at the beginning of August and the full Consolidated Application is due by October 30th. This year's grant will be a two-year grant cycle, eligible to all projects expiring in 2025.
 - We are already in process with our new project applications (we began this process in May 2024 <u>See HERE</u>) and are working with new projects to adjust their proposals through Sept. 3. Renewal projects can expect a renewal application in the coming days.
 - Of note, there is an increase in renewal funding and larger bonus offerings due to cost of living increases. The CoC bonus is double the initial expectation, and the DV bonus is also larger than anticipated. There is a new rural cost budget line and VAWA budget for renewal projects in Vermont. These budget lines include short-term emergency lodging, repairs to housing units, staff training, and cost of living adjustments. All Vermont BoS CoC counties are included in the rural geocodes. Reminder for renewal projects that there is a flexibility in budget line items within a 10% shift for renewals. Projects must continue to serve their designated populations, such as survivors of domestic violence or young people experiencing homelessness.
