10:20 VT Legal Aid Update on GA Program Decision with Maryellen Griffin, VT Legal Aid

- The Vermont Human Services Board decided that everyone's 80 days of GA emergency housing did reset at the start of the new fiscal year (July 1st) for those who qualify under the current eligibility requirements. This decision was made because the language of the budget bill that funds the emergency housing program only referenced FY26.
- ESD is not implementing this decision across the board and is still telling people that they have used their 80 days.
- Clients who want to appeal their denial should state on the phone that they want to appeal to the Human Services Board and ask for their denial notice in writing (via email).
- Clients can also ask for benefits pending appeal to start using housing in the meantime.
- Vermont Legal Aid is close to their limit of how many people they can help with their appeal process, so they are asking service providers to assist in their clients' appeal processes. Their representative doesn't have to be an attorney.
- So far, Legal Aid is not seeing people lose their appeal if they qualify under the current eligibility requirements.

10:40 HHAV Organizational & Legislative Update, Frank Knaack

- There is a possibility of a special session at the Vermont Legislature on how to respond to the federal cuts, but it's not likely to happen as federal budget decisions are delayed it will likely be addressed in the regular session starting in January.
- Trump proposed a federal budget that would have a harsh impact on communities we serve the proposal would put ESG & CoC funding into a block grant and reduce them.

- But both congress and senate versions of the budget don't do that & continue to have separate line items for ESG & CoC.
- The budget seems somewhat more positive than it did a few months ago, but even if funds get approved legislatively it is possible/likely that the executive branch would not spend the funds or pass it down to the states, and the issue could go to the Supreme Court.
- Trumps Executive Order on unhoused populations targets folks with mental health conditions and substance use disorders and would use confinement as a response to unhoused populations. Its focus is on deprioritizing housing first and pushing mandatory treatment as part of getting access to benefits. Its left to various agency heads to come up with an implementation process, and so far we have not heard anything about that.

- HHAV Annual Meeting will be on Tuesday, September 9th at Judd Hall, Vermont State University Campus.
- 11:00 Extreme Weather Shelter through Vermont Interfaith Action (VIA) Rick DeAngelis
 - VIA received an award from the state to help encourage and support a network of extreme cold weather shelters in Vermont.
 - Open to funding either a stand-alone shelter or any other shelter that wants to provide additional beds.
 - The purpose is to prevent cold related illness and death this winter. The program will run from Dec 1 April 1, 2026. Expected up to 20 nights, activation will be at -10 degrees Fahrenheit or below including windchill.
 - There will be an application process in early September, with a decision by October. Reimbursable costs include personnel/operations, utilities/services, supplies/equipment, and infrastructure. Targeting 6 communities Burlington, Rutland, Bennington, Montpelier/Barre, NEK, Brattleboro.
 - \$900,000 are available for funding.
