- Welcome Michael Redmond as our Interim HHAV Executive Director!
  - Michael started Monday, November 17<sup>th</sup>. Erhard Mahnke has also joined the team as our Interim Policy Advisor and will work alongside our lobbyists David and Christina.

- FY25 NOFO Update
  - O The NOFO was released on November 13<sup>th</sup> when the government reopened. Everything that we were expecting and have been communicating to the board was in the NOFO nothing was a surprise, and we are prepared. We do have longer than anticipated to submit until January 14<sup>th</sup>. We are working on a timeline and gameplan with our consultant and applicants and will keep everyone posted on our local competition on our website and listserv. There is a 30% cap on permanent housing all components. Only 30% of our Annual Renewal Demand (ARD) is protected this year, which means 70% of our funding is up for national competition we will work hard to retain funding for our state. We will go for bonus funding as always.
- 10:15 Presentation from Jason Brill, VT BoS CoC Veterans Representative, on updates regarding the Veterans' Committee work
  - Jason presented on proposed changes to the governance charter as it relates to the Veterans Committee being a subcommittee of the Balance of State. The Committee has been around since 2015, and a committee of BoS and CCHA since 2019, and the committee has decided to separate from the CoCs it has already done so from CCHA. The reasoning is that the committee feels that its priorities have remained the same despite the changing goals and priorities of the world around it. There has been a push

from the VA to use a One Team approach, and the concept does not align with the VT Committee to End Veteran Homelessness. The Committee will be reshaped to include Vermont and New Hampshire providers to be able to work on the issues of the VA nationally, to place veterans on pathways to permanent housing, perform outreach to veterans experiencing unsheltered homelessness, etc.

- Jason will remain on the VT BoS CoC board and all organizations currently providing CE services and assessments will continue to do so, so there will be no changes to representation for veterans in the CoC or in the CE system.

- Notable changes:
  - o Board member engagement policy added
  - o Removed secretary from board officers
  - o Co-chairs may serve up to four consecutive terms
  - o Each committee will have a governance charter
  - o Membership committee hosts the PLEE Committee
  - Vermont Veterans Committee on Homelessness (VVCH) is no longer a committee of the Balance of State Continuum of Care.
  - o Local Coalition Leadership Committee added as an official committee
  - o DV/SV committee added as official committee
  - o CCHA-BoS CoC Joint Policy Committee added as official committee
  - o Additional updated language on pages 9-10

- 10:45 Update on the Point in Time Count with Institute for Community Alliances, Meghan Morrow Raftery, HMIS Manager
  - The PIT Count will be held the fourth Wednesday of January, which is the 28<sup>th</sup>, from 6pm until 6pm the next day. After that you have 5-7 days to continue collecting that data to ask where people stayed that night. ICA is in touch with ESD this year, who will be entering the 1 night data into HMIS.
  - No actual HUD update about PIT or HIC. When we do hear, we expect the update will be that gender will not be collected, just sex data.
  - ICA will be putting out training, communication, office hours, and sending out newsletters everything will be on ICA's Knowledge Base & HHAV's website.
- 10:55 Presentation on use of HOP Funds by VT Network, Kara Casey, Director of Housing Training and Technical Assistance
  - The Vermont Network is a statewide organization that receives HOP funds they do a presentation to the BoS CoC because they don't have a local CoC.
  - Received a total of \$194,302
    - \$24,000 of that goes to HMIS comparable databases DV/SV organizations are statutorily prohibited from entering survivor data into shared databases, so VT Network provides comparable databases.

- o \$165,119 in financial assistance: security deposits, rental assistance, rental arrears, transportation costs, etc. Majority of this was security deposits.
- Supported 95 unduplicated households, 52 were homeless at the time of assistance,
   42 at risk
- Presentation next year will look very different because they are receiving funding to subgrant to DV/SV shelters and providing training/technical assistance.
